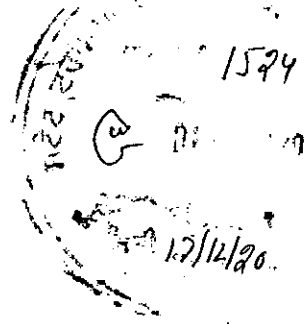

In exercise of the powers conferred by Rule 42-A of the Punjab Motor Vehicles Rules, 1989, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to partially amend the Government of Punjab, Department of Transport (Transport-II Branch) Notification No. 10/51/2017-1T2/1163 dated 19th October, 2020, namely:-

AMENDMENT

1. In the said notification, under the heading the process of e-auction:-
 - (i) **in Sr. no. 2, for entry** "The registration window shall be open from 9:00 am on every Sunday till Tuesday (12:00 midnight), the bidding will take place from Wednesday (12:01 AM) till Thursday(12:00 midnight) and the payment period for successful bidder will be from Friday(12:01 AM) till Saturday(12:00 midnight) on the online e-auction platform. This facility will be available on Gazetted holidays also.

Registration: Sunday (9:00 AM) to Tuesday (12:00 midnight) (Day 1, Day 2 & Day 3)
Bidding : Wednesday(12:01 AM) to Thursday(12:00 midnight)(Day 4 & Day 5)
Payment by successful bidder : Friday (12:01 AM) till Saturday (12:00 midnight)(Day 6 & Day 7)"

the following entry shall be substituted, namely:-

"The registration window shall be open from 9:00 am on every Sunday till Tuesday, the bidding will take place from Wednesday (12:01 AM) till Thursday (10:00 PM) and the payment period for successful bidder will be from Thursday (10:01 PM)till Saturday(12:00 midnight) on the online e-auction platform. This facility will be available on Gazette holidays also.

Registration: Sunday (9:00 AM) to Tuesday (12:00 midnight) (Day 1, Day 2 & Day 3)
Bidding : Wednesday(12:01 AM) to Thursday(10:00 PM)(Day 4 & Day 5)
Payment by successful bidder: Thursday (10:01 PM) till Saturday (12:00 midnight)(Day 5,Day 6 & Day 7)."

(ii) **in Sr. no. 15, for entry** "The allotment of reserved numbers shall be valid for 15 days from the date of issue of the allotment letter. If the vehicle owner does not register his vehicle within 15 days, the allotment of the reserved number shall automatically stand cancelled and the amount deposited will be forfeited and no refund shall be given. The allotted reserved number will be released and available to public in further e auction.", **the following entry shall be substituted, namely:-**

"The allotment of reserved numbers shall be valid for 4 weeks from the date of issue of the allotment letter. If the vehicle owner does not register his vehicle within 4 weeks, the allotment of the reserved number shall automatically stand cancelled and the amount deposited will be forfeited and no refund shall be given. The allotted reserved number will be released and available to public for further e auction."

2. This notification will come into force w.e.f. 10.12.2020.
