The Complete online networking solution includes Customized Software, hardware, lease line, server/ cloud server, SMS sending, notice generation etc. Online system means the PUC Check center will be connected to centralized server through any ISP while testing the vehicle using its unique user ID and password. In case the system is not logged on to server, no test should be performed. The PUC check centers should always remain connected to the centralize server through Internet Service Provider (ISP) to the portal, else the front-end software application will not perform the test. Hence, it will only be an on-line testing. The new PUC Centers at par with the old centers.
